Matters Arising from April 2013 Meeting:

The Secretary reported he had not received any further advice from the TCC's lawyers concerning the lack of response from Queanbeyan City Council (QCC) to the TCC's request for an explanation over a letter to the editor to The Canberra Times, which the TCC believed had been authored by a QCC executive.

President's Report (Mr Nick Tsoulias):

President, Nick Tsoulias presented the following Report:

"Thank you for joining us for another meeting of the Tuggeranong Community Council.

During the month of April the TCC Executive attended a community forum in South Tuggeranong hosted by Mick Gentleman MLA. The Chief Minister opened the forum and took a diverse range of questions from the floor. The meeting was also attended by the Lanyon Residents Forum, residents from Chisholm and SETRA. Two weeks ago I was joined by our Treasurer Frank Vrins, Federal Member for Canberra Gai Brodtmann MP, Tuggeranong Hyperdome Manager Jodie Marques to launch the TCC petition to call on the House of Representatives to do all in its power to:

- Maintain and improve existing public service jobs that are located in the Tuggeranong region; and
- To locate in Tuggeranong CBD the required 40,000 to 42,000 square metres of space that is needed to house the newly consolidated Commonwealth Government Department of Families, Housing, Community Services and Indigenous Affairs.

I am pleased to announce our progress to date that we have around 500 signatures of support from all of you and our community thus far. For those residents wishing to support this, the petition will be available at the Hyperdome Management offices, and both at the Federal Member for Canberra Gai Brodtmann's office, and Senator Gary Humphries' office in Canberra City. The petition has also been circulated as widely as possible, and the TCC executive tonight urges you all to sometime during tonight's meeting to support and sign this petition, which can be done anytime throughout the evening. Our Vice President, Mr Russ Morison, has been actively meeting with the residents of Banks to see a balanced outcome for next week's auction of land at the Banks Shops.

Finally, a reminder to all members that the there is a Tralee forum being possibly planned for 13th June. This forum is being organised by Federal Member for Canberra Gai Brodtmann MP and we will keep you all informed about this important forum. Only today the TCC sent its reply to the Canberra Airport and Village Building Group informing both these groups about the upcoming forum that may be held on the 13th June or later this year. The TCC also asks all financial members and any new members wanting to sign up as a new member or renew their annual membership to do so in the coming months. We have a great bunch of members on these sub committees who over the years have contributed to keeping a strong Council. I am also happy to say our attendance at TCC meetings has grown slightly over the last 6 months as the Club and our Treasurer have reported good attendances.

As tonight we have a number of speakers, I will encourage a good transparent meeting, and urge members to ask constructive questions that will benefit both our Council and our guest speakers."

As at 7 May 2013 the balance was \$19,276.70 comprising of \$1,384.59 in the Operating account and \$17,892.11 in the Investment account. Total expenditure was \$1,458.79, comprising of \$465.26 office costs and \$993.53 for insurance.

Eric Traise advised members the NSW Government was seeking public comment on proposals to exclude certain areas close to Canberra Airport from future development. The TCC will lodge a submission.

Police Report:

Sergeant Daryl Neit presented the following brief report on crime statistics and information regarding other local Police activities during April:

- Increase in burglaries, property damage, assaults and stolen motor vehicles and number plates.
- 36 people arrested over March for various offences from breach of bail, outstanding warrants and traffic related offences.
- Police attended 819 jobs over the month.
- ACT police new roster trial underway. More proactive police operations out in the field and frees up over 50 police, resulting in:
 - o Over 2000 RBT tests.
 - o 48 traffic offences detected
 - o 4715 RAPID scans
 - o 88 drug tests
 - o 10 on the spot fines issued
 - o 6 arrests for drunkenness
 - o 30 hours visiting licensed premises
